Balloting

Balloting will be used to determine the order of priority. The person(s) or company(ies) interested in purchasing any of the specified residential properties ("the registrant(s)") must follow the procedures below:-

Group B1 and Group B

- 1. To participate in the balloting, interested persons and previous Group B registrants who apply the "Renewal Registration" procedures must first submit a registration of intent using Registration of Intent Form B1 ("Group B1 Registration of Intent").

Card of the Director of the registrant (if applicable) and the official receipt for the Registration of Intent. (c) Group B1 and Group B

- (i) Where a registrant selects only one specified residential property in respect of a Registration of Intent, the purchaser(s) of that specified residential property shall only be:
 - (1) That registrant; or
 - (2) That registrant together with one or more "Immediate Family Members" of that registrant whom that registrant requests the Vendor on spot to add as joint purchaser(s).
- (ii) Where a registrant selects more than one specified residential property in respect of a Registration of Intent:
 - (1) The purchaser(s) of at least one so selected specified residential property shall only be:
 - I. That registrant; or
 - II. That registrant together with one or more "Immediate Family Members" of that registrant whom
