第二按揭貸款於貸款提款日（「貸款提款日」）起息，選用第二按揭貸款的買方於貸款提款日起計首兩年內免供本金，只須按月支付利息。賣方並無就其作出，或不得被視為就其作出任何不論明示或隱含之陳述、承諾或保證。
Interest on the Standby Second Mortgage Loan will accrue from the day of drawdown ("Loan Drawdown Date"), the Purchaser who chooses Standby Second Mortgage Loan will not be required to repay the principal thereof, but is obliged to pay interest thereon on a monthly basis during the first 2 years from the Loan Drawdown Date.
