The Vendor has the absolute right to change the closing date and/or time of the tender in respect of all or any of the specified residential properties from time to time by amending and/or issuing Sales Arrangements.

Please also note that the register of transactions of the Development may not be updated immediately after the Vendor accepts a tender.
