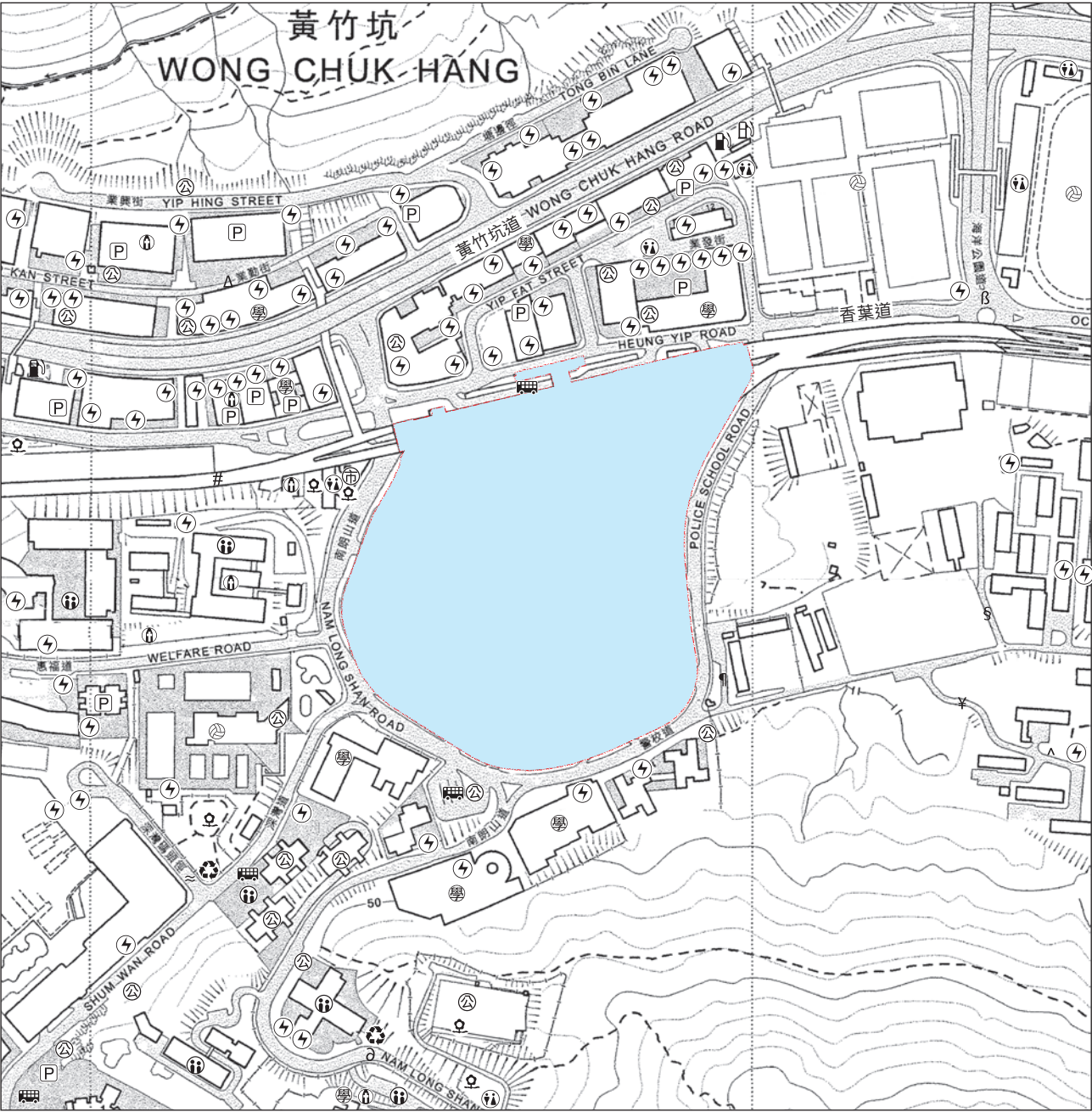


Location plan of the development
