The Vendor may consider giving higher priority to a tenderer or (if applicable) corporate tenderer(s) with common director(s) submitting the highest number of tenders. The Vendor has the absolute right to reject any tender or withdraw from the sale of any specified residential property at any time before the acceptance of any offer.
