The Vendor may consider giving higher priority to a tenderer or (if applicable) corporate tenderer(s) with common director(s) submitting the highest number of tenders. The Vendor has the absolute right to reject any tender or withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to change the closing date and/or time of the tender in respect of all or any of the specified residential properties from time to time by amending and/or issuing Sales Arrangements.

Please also note that the register of transactions of the Development may not be updated immediately after the Vendor accepts a tender.
